1. Only individual(s) of at least 18 years old or limited company(ies) incorporated in Hong Kong or non-Hong Kong company(ies) registered under Part 16 of the Companies Ordinance (At least one director of such limited company or non-Hong Kong company shall be natural person) shall be eligible to submit tenders. 只有年滿 18 歲的個人或香港註冊的有限公司或根據公司條例第 16 部註冊的非香港公司(該有限公司或非香港公司須最少有一位董事為自然人)方有資格遞交標書。

2. Any tender must be made in the Form of Tender (in prescribed form) signed by the tenderer which together with other relevant tender documents shall be enclosed in a sealed envelope and placed in the specified Tender Box located at Unit 3, Level 2, The Long Beach, No. 8 Hoi Fai Road, Kowloon, Hong Kong (the "Sales Office") from 10:00 a.m. on 5 June 2017 to 2:00 p.m. on 5 June 2017 (“Tender Closing Time”).

Notwithstanding anything herein provided, if typhoon signal no.8 or above is hoisted or black rainstorm warning is issued in Hong Kong at any time between 10:00 a.m. on the day on which the Tender Closing Time falls and the Tender Closing Time, the Tender Closing Time will automatically be postponed to 2:00 p.m. on the next succeeding working day.
